**Title:** AN ACT CONCERNING THE COURTS OF PROBATE.

**Statement of Purpose:** To: (1) Revise the method for calculating probate fees, (2) revise provisions regarding retirement credit for judges and clerks whose probate districts have been merged with another district, (3) revise the approval process for certain regulations, (4) revise an alternate method of calculating a probate judge's compensation, (5) provide that health insurance coverage for probate judges and Probate Court employees be paid from funds appropriated by the General Assembly, and (6) repeal certain provisions regarding amendments to probate appeals.
