1 In line 85, strike "sequence support" and insert "sequential" in lieu
2 thereof

3 In line 93, strike "and (5)" and insert the following in lieu thereof:
4 "(5) recommendations concerning the transition between the beginning
5 educator support and training program and the mentor assistance
6 program, including, but not limited to, an evaluation process and
7 procedures concerning initial educators who completed one or more
8 professional knowledge clinical assessments, but have not received a
9 satisfactory evaluation by June 30, 2009, (6) recommendations
10 concerning possible exemptions from the mentor assistance program
11 for educators who taught previously in another state, taught
12 previously in a nonpublic school or have teaching assignments for
13 which such program may not be relevant and any other situation for
14 which the task force determines that an exemption may be
15 appropriate, and (7)"

16 Strike lines 111 to 126, inclusive, in their entirety and substitute the

28 of Administrators of Special Education and one of whom is a member
29 of the Connecticut Education Association;

30 (6) Two appointed by the majority leader of the Senate, one of
31 whom is a member of the Connecticut Association of Private Special
32 Education Facilities and one of whom is a member of the Connecticut
33 chapter of the American Federation of Teachers;

34 (7) Two appointed by the minority leader of the House of
35 Representatives, one of whom is a member of the Connecticut
36 Association of Boards of Education and one of whom is a member of
37 the Connecticut Parent Teacher Association;

38 (8) Two appointed by the minority leader of the Senate, one of
39 whom is a member of the Connecticut Parent Teacher Association and
40 one of whom is a teacher in a public school who holds an initial
41 educator certificate; and"
