Resolved by this Assembly:

- 1 That the recommendation of the Claims Commissioner, file number
- 2 21543 of said commissioner, that an award of twenty thousand eight
- 3 hundred seventy-three dollars and fifty-eight cents, payable from the
- 4 appropriation to the Department of Public Safety, be granted to
- 5 Hallmark Totaltech, Inc. on its claim against the state in excess of seven
- 6 thousand five hundred dollars, is accepted and that payment of said
- 7 amount to said claimant is ordered.
