Resolved by this Assembly:

- 1 That the recommendation of the Claims Commissioner, file number
- 2 21229 of said commissioner, that an award of twenty thousand five
- 3 hundred seventy-two dollars and eighty cents, payable from the
- 4 appropriation to The University of Connecticut Health Center, be
- 5 granted to Yale University on its claim against the state in excess of
- 6 seven thousand five hundred dollars, is accepted and that payment of
- 7 said amount to said claimant is ordered.
