**AN ACT NAMING ROADS AND BRIDGES IN MEMORY OR IN HONOR
OF PERSONS OR ORGANIZATIONS AND REQUIRING THE
INSTALLATION OF SIGNS FOR DESTINATIONS OF INTEREST.**

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. (*Effective from passage*) The bridge on Route 4 in
2 Farmington shall be named "Vincent DiPietro Memorial Bridge".

3 Sec. 2. (*Effective from passage*) The name of the Route 411 bridge in
4 Rocky Hill shall be changed from "John L. Levitow Memorial Bridge"
5 to "John L. Levitow, S/Sgt. U.S. Air Force and Medal of Honor
6 Recipient Memorial Bridge".

7 Sec. 3. (*Effective from passage*) Stratford Avenue in Stratford shall
8 have a ceremonial designation placed beneath its name in honor of
9 Rev. Dr. William O. Johnson.

10 Sec. 4. (*Effective from passage*) A portion of Route 309 in Simsbury
11 shall be named "Sergeant Felix M. Del Greco, Jr. Memorial Highway".

12 Sec. 5. (*Effective from passage*) Route 22 in New Haven, west of U.S.
13 Route 5, shall be named "Amvets Post No. 9 Highway".

14 Sec. 6. (*Effective from passage*) The portion of Route 10, Main Street, in
15 central Southington, from the intersection of Berlin Avenue to High
16 Street, shall be named "Police Chief Tom Foley Memorial Highway".

17 Sec. 7. (*Effective from passage*) Route 66 through East Hampton shall
18 be named "Governor William A. O'Neill Memorial Highway".

19 Sec. 8. (*Effective from passage*) The segment of Route 337 along the
20 seawall in New Haven shall be named "Julia 'Nana' Coppola Memorial
21 Highway".

22 Sec. 9. (*Effective from passage*) Bridge number 00608 on Route 8 near
23 the Harwinton/Litchfield town line shall be named "Trooper James
24 Savage Memorial Bridge".

25 Sec. 10. (*Effective from passage*) The segment of Route 22 in North
26 Branford known as Notch Hill Road, between Route 1, Boston Post
27 Road, at the intersection of the Branford, Guilford and North Branford
28 town lines, to Route 80, Foxon Road, in Branford shall be named
29 "Beverly D. Tulli Memorial Road".

30 Sec. 11. (*Effective from passage*) The segment of Route 82 in Salem
31 between Salem Four Corners and Route 11 shall be named "Officer H.
32 David Cordell Memorial Highway".

33 Sec. 12. (*Effective from passage*) The segment of Route 2, eastbound,
34 from Hartford to Glastonbury shall be named "Marine Scout Sniper
35 Sgt. David Coullard Memorial Highway".

36 Sec. 13. (*Effective from passage*) The segment of Route 30 from the
37 Vernon town line to the South Windsor town line shall be named
38 "Captain Patrick Reeves Memorial Highway".

39 Sec. 14. (*Effective from passage*) The section of Route 4 in Farmington,
40 running in an easterly direction from Route 10 to the junction of State
41 Road 508 shall be named "Colonel Everett H. Kandarian Memorial
42 Highway".

43 Sec. 15. (*Effective from passage*) Bridge number 6065 over the Norwalk
44 River, on Route 7 in Norwalk shall be named "Robert Mugford
45 Memorial Bridge".

46 Sec. 16. (*Effective from passage*) The Department of Transportation
 47 shall place informational signs at Exit 37 on Interstate 91 for the
 48 Antique Radio Museum.

49 Sec. 17. (*Effective from passage*) The Department of Transportation
 50 shall place a sign in an appropriate location on Interstate 95,
 51 northbound and southbound, indicating the location of the
 52 Connecticut River Museum in Essex.

53 Sec. 18. (*Effective from passage*) The Department of Transportation
 54 shall install "tourist destination" directional signs on Route 1,
 55 northbound and southbound, and Route 156, southbound, for
 56 Veterans Memorial Green in Waterford, at the intersection of Route 1
 57 and Route 156.
