Title: AN ACT REQUIRING MANDATORY RETESTING OF KNOWLEDGE OF DRIVING LAWS PRIOR TO THE ISSUANCE OF A MOTOR VEHICLE OPERATOR'S LICENSE TO A PERSON WHO IS SIXTEEN OR SEVENTEEN YEARS OF AGE.

Statement of Purpose: To improve public safety by requiring that a comprehensive test as to knowledge of the laws concerning motor vehicles and the rules of the road be given prior to the issuance of a motor vehicle operator's license, in addition to the test concerning such laws and rules given prior to the issuance of a learner's permit.
