Title: AN ACT CONCERNING STANDARDS FOR THE SELECTION, RETENTION AND PROMOTION OF JUDICIAL MARSHALS.

Statement of Purpose: To (1) make the process for selecting judicial marshals transparent and provide a means to hold the Judicial Department accountable for decisions in selecting judicial marshals by requiring the Judicial Department to establish employment standards and to make such employment standards publicly available on its Internet web site, and (2) reduce the period of inquiry with respect to motor vehicle infractions and violations and misdemeanor offenses.
