Title: AN ACT CONCERNING THE COLLECTION OF DELINQUENT TAXES AND LOTTERY WINNINGS.

Statement of Purpose: To require the Connecticut Lottery Corporation to compare the name of any winner of a lottery prize of five thousand dollars or more against a list of delinquent taxpayers compiled by the Department of Revenue Services, and if the lottery winner is on said list, to deduct the amount of delinquent taxes and any other applicable penalties or interest from the lottery winnings.
