Title: AN ACT CONCERNING THE INSPECTION OF ELEVATORS, THE AUTHORITY OF THE STATE AND LOCAL FIRE MARSHALS, THE REGULATION OF EXPLOSIVES AND OTHER TECHNICAL CHANGES.

Statement of Purpose: To clarify that elevators in private residences are inspected only upon the request of the owner, to delete an obsolete exception for manufacturing facilities, to allow the deputy fire marshal or acting fire marshal to act in the place of a local fire marshal when there is no local fire marshal, to permit the State Fire Marshal to grant variances from certain regulatory provisions concerning the storage, transportation or use of explosives, to remove the right to a hearing for a new applicant for a demolition certificate of registration and to permit the department to require an examination for such registration.
