**Title:** AN ACT CONCERNING HOMEOWNERS INSURANCE POLICY PREMIUMS.

**Statement of Purpose:** To prohibit an increase in the rate of a homeowners insurance policy because of a damage claim arising from a home invasion and to require, in the event of an increase in the rate of a homeowners insurance policy or the imposition of a penalty because of a claim other than one arising from a home invasion, written disclosure of the specific amount of the increase or penalty attributable to the claim, the duration such increase or penalty shall be in effect and the date such increase or penalty will be removed.
