Title: AN ACT MITIGATING FIRE LOSSES FOR HOMEOWNERS AND BUSINESS OWNERS.

Statement of Purpose: To reduce the waiting period when a fire loss claim is payable after submittal of proof of such loss, to extend the period during which a suit or action may be commenced for recovery of a claim, and to specify that a master policy purchased by a condominium association is not excluded from coverage of insured perils caused by terrorism.
