Title: AN ACT CONCERNING CONNECTICUT STATE SINGLE AUDIT REVISIONS.

Statement of Purpose: To (1) increase the amount of state financial assistance that must be expended in order to trigger a state single audit; (2) make the revenue criteria provisions of the State Single Audit Act consistent with those in section 7-391 of the general statutes regarding audited agencies; (3) add definitions and procedures that conform to and more closely mirror the federal government's single audit act provisions, so as to promote a better understanding of audit requirements; and (4) clarify that an entity being audited is responsible for paying the cost of an audit in a case where a cognizant agency designates an independent auditor.
