Title: AN ACT INCREASING THE PENALTY FOR FOREIGN CORPORATIONS AND OTHER ENTITIES THAT TRANSACT BUSINESS OR CONDUCT AFFAIRS IN THIS STATE WITHOUT AUTHORITY.

Statement of Purpose: To increase the monthly penalty levied by the Secretary of the State upon a foreign corporation, limited partnership, limited liability company, registered limited liability partnership or statutory trust that transacts business or conducts affairs in this state without a certificate of authority or registration.
