Title: AN ACT CONCERNING REVISIONS TO VARIOUS STATUTES CONCERNING THE CRIMINAL JUSTICE SYSTEM.

Statement of Purpose: To fully integrate juvenile prosecutors into the Division of Criminal Justice, to expedite the provision of sentencing transcripts to the Board of Pardons and Paroles, to limit access by the Division of Public Defender Services to certain information in the state-wide criminal justice information technology system, to revise the elements of the crime of failure to appear, to facilitate the prosecution of sexual assault cases involving child victims, to provide for judicial discretion in the sentencing of teenagers in certain sexual assault cases, to revise the penalty for failing to appear for jury duty and the agency responsible for enforcing such violation, to facilitate the investigation and prosecution of forgery and to make youthful offender records available to law enforcement and prosecutorial officials conducting criminal investigations.
