Title: AN ACT CONCERNING THE DEPARTMENT OF CORRECTION.

Statement of Purpose: To prohibit disclosure of employee files to inmates, prohibit the possession of an electronic wireless communication device by an inmate, revise provisions concerning inmate discharge savings accounts, prohibit the disclosure of the identity of execution teams, authorize the release of inmates to the Bureau of Immigration and Customs Enforcement, require the department be notified when a request is made to a public agency for disclosure of information about a correctional facility and allow an inmate to remain in a correctional facility beyond the inmate's discharge date.
