**Title:** AN ACT CONCERNING COURT OPERATIONS.

**Statement of Purpose:** To: (1) Authorize action necessary to ensure operation of the state courts in an emergency; (2) enact provisions regarding electronic records, signatures and filings; (3) increase the dollar limit of projects for the alteration, repair or addition to Judicial Branch facilities that remain under the control of the Judicial Branch; (4) amend provisions concerning state marshals and probations officers; (5) add family relations counselors to the statutory list of mandated reporters; (6) eliminate the statutory cap on the cost of electronic monitoring; (7) make other changes related to court operations, records and the Judicial Branch budget process; (8) require a court to include in any visitation order a statement on conditions and obligations of the noncustodial parent with respect to such visitation rights; and (9) enhance the penalty for perjury in certain family matters.
