Title: AN ACT CONCERNING THE SENTENCING OF DRUNKEN DRIVERS.

Statement of Purpose: To prohibit the operation of a motor vehicle for a specified time period by a person convicted for the first time of drunken driving unless the motor vehicle is equipped with an ignition interlock device and to give judges the discretion in certain cases to sentence a person convicted of drunken driving to house arrest and monitoring by a global positioning system device and an alcohol consumption device rather than sending such person to prison.
