Title: AN ACT CONCERNING THE DISABLED VETERANS' PROPERTY TAX EXEMPTION.

Statement of Purpose: To implement the Governor's budget recommendations by providing that a disabled veteran who receives a property tax exemption under subdivision (20) of section 12-81 is not required to submit proof of his or her disability rating each year in which the exemption is being sought and that such veteran is required to submit proof of his or her disability rating only if said rating is modified by the Veterans' Administration of the United States.
