Title: AN ACT CONCERNING VARIOUS REVENUE MEASURES.

Statement of Purpose: To make various technical changes and corrections, to provide a ten per cent penalty for failure to file cigarette taxes, to publicly identify certain persons for purposes of cigarette tax administration, to transfer responsibility for making transfers to the Conservation Fund to the Comptroller, to exempt in-state motor carriers from filing certain quarterly reports, to provide for issuance of a trip permit for motor carriers that do not normally travel in this state, to provide for application of certain tax provisions to the captive insurers premium receipts tax, and to repeal two statutes, one an outdated statute that established the State Tax Review Commission, and the other requiring a report on cigarette enforcement efforts.
