**Title:** AN ACT CONCERNING MEDICAL MALPRACTICE DATA REPORTING.

**Statement of Purpose:** To add clarifying definitions, to expand closed claim reporting requirements to risk retention groups, captive insurers, unauthorized insurers and facilities and providers named in such claims, to grant the Insurance Commissioner the authority to fine entities that fail to submit reports as required, and to add confidentiality provisions.
