Title: AN ACT CONCERNING MURDER AND INHERITANCE.

Statement of Purpose: To prohibit the estate of a criminal actor in a murder-suicide, or the estate of any other person who intentionally or, under certain circumstances, recklessly causes the death of another and dies prior to being adjudged guilty, from benefiting from the estate of the decedent or from the decedent's life insurance policy or annuity if the court finds that the person would have been adjudged guilty of killing the decedent had the person survived.
