**Title:** AN ACT CONCERNING A SURETY BOND GUARANTEE PROGRAM FOR EMERGING CONTRACTORS.

**Statement of Purpose:** To assure fair opportunities to subcontractors by (1) removing the requirements that subcontractors must prequalify for public bids and provide bonds where the contractor is bonded, (2) providing that experience in determining eligibility for a certificate of registration for demolition work be based on hour of services, and (3) requiring the Department of Transportation to establish a program of mediation for disputes with subcontractors arising from contracts with the department.
