Title: AN ACT CONCERNING THE COLLECTION AND DISCLOSURE OF SOCIAL SECURITY NUMBERS.

Statement of Purpose: To protect an individual's privacy and reduce the opportunity for identity theft by requiring state and local agencies that request an individual's Social Security number to disclose whether providing such number is mandatory or voluntary, the authority for making such request and the uses to which such number will be made and by revising the requirements that businesses must follow to protect the confidentiality of such numbers.
