Title: AN ACT CONCERNING COMPLAINTS PENDING IN THE DEPARTMENT OF PUBLIC HEALTH AGAINST PHYSICIANS AND OTHER HEALTH CARE PROVIDERS.

Statement of Purpose: To: (1) Permit a patient, or the patient's representative, to obtain information about the status of the patient's complaint against a health care provider filed with the Department of Public Health or a regulatory board within the department, and (2) allow the patient, or the patient's representative, to provide testimony regarding such complaint prior to a final decision on the complaint.
