"AN ACT MANDATING EMPLOYERS PROVIDE PAID SICK LEAVE TO EMPLOYEES."

1 After the last section, add the following and renumber sections and
2 internal references accordingly:

3 "Sec. 501. (NEW) (*Effective from passage*) (a) Any member of the
4 Senate may submit a complaint, under penalty of false statement,
5 concerning alleged misconduct by a member of the Senate to the
6 president pro tempore and the Senate minority leader. Not later than
7 seven days after receipt of such a complaint, the president pro tempore
8 shall appoint a bipartisan committee on ethics that shall consist of six
9 members, three of whom shall be appointed with the concurrence of
10 the Senate minority leader. The president pro tempore shall appoint
11 two cochairpersons of the committee, one of whom shall be appointed
12 upon the recommendation of the Senate minority leader.

13 (b) Said committee shall have cognizance of any official Senate

14 action in response to any such complaint of misconduct by any
15 member of the Senate. As used in this section, "misconduct" means any
16 violation of state or federal election laws, any violation of the state
17 codes of ethics, any misuse of state property or time, including, but not
18 limited to, the submission of a false claim for reimbursement for time
19 or expenses, any form of illegal discrimination, any legal or ethical
20 wrong or other conduct that materially impairs the ability of the
21 member to perform the duties of his or her office or undermines public
22 trust and confidence in the Senate. Nothing in this section shall be
23 construed to affect the powers and duties of the Office of State Ethics
24 or the Citizen's Ethics Advisory Board.

25 (c) A quorum, consisting of not less than two members of each
26 caucus, shall be required to conduct any official business of the
27 committee. All committee decisions shall require four affirmative
28 votes.

29 (d) In the event that a complaint concerns alleged misconduct by the
30 president pro tempore, the duties of the president pro tempore under
31 this section shall become the duties of the Senate majority leader. If
32 such complaint concerns alleged misconduct of the Senate minority
33 leader, the duties of the Senate minority leader under this section shall
34 become the duties of the Senate minority leader pro tempore.

35 (e) The committee shall conduct a preliminary investigation into any
36 such complaint of misconduct by any member of the Senate. Any such
37 preliminary investigation of a complaint shall be confidential and not
38 subject to disclosure. Upon the conclusion of any preliminary
39 investigation, the committee shall vote to either (1) dismiss the
40 complaint, or (2) make a finding of probable cause that misconduct has
41 occurred. Upon a finding of probable cause by the committee, all
42 information relating to the preliminary investigation shall, to the
43 extent allowed by state and federal law, be made available to the
44 public.

45 (f) The committee shall undertake a full investigation only after a

46 finding of probable cause. All information relating to a full
47 investigation shall, to the extent allowed by state and federal law, be
48 made available to the public. All proceedings relating to a full
49 investigation shall be open to the public. Upon the completion of a full
50 investigation, the committee shall report its findings and
51 recommendation in the form of a resolution to be voted upon by the
52 Senate. Such recommendation shall include one of the following: (1)
53 Expulsion, (2) censure, (3) reprimand, or (4) no action. The full Senate
54 shall vote on any such resolution not later than ten days after the
55 committee reports out any such resolution.

56 (g) The subject of any such complaint or investigation may be
57 represented by counsel and may appear before the committee on his or
58 her own behalf.

59 (h) The committee shall adopt rules and procedures to govern its
60 proceedings. Such rules shall include, but not be limited to, standards,
61 rules and methodology for conducting such preliminary and full
62 investigation, respectively."
