AN ACT CONCERNING AN EDUCATION DOCTORAL DEGREE PROGRAM IN NURSING EDUCATION.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. Section 10a-149 of the 2010 supplement to the general
2 statutes is repealed and the following is substituted in lieu thereof
3 (*Effective October 1, 2010*):

4 In addition to other powers granted in the general statutes,
5 authority and responsibility for the operation of the state's public
6 institutions of higher education shall be vested in (1) the Board of
7 Trustees of The University of Connecticut which shall have exclusive
8 responsibility for programs leading to doctoral degrees and
9 postbaccalaureate professional degrees, with the exception of
10 education doctoral degree programs, (2) the Board of Trustees of the
11 Connecticut State University System which shall have special
12 responsibility for the preparation of personnel for the public schools of
13 the state including master's degree programs, education doctoral
14 degree programs, including an education doctoral degree program in

Explanation

The Connecticut State University system can offer a doctoral degree in nursing education by reallocating existing resources from other areas with less demand, and sharing resources such as faculty, library holdings and facilities resulting in no cost to the state. The estimated initial cost of the program will require the reallocation of approximately \$100,000 in the resources noted above.

The Out Years

The program will require the reallocation of approximately \$200,000 in resources including faculty, library holdings and facilities at full implementation.

HB 5024

AN ACT CONCERNING AN EDUCATION DOCTORAL DEGREE PROGRAM IN NURSING EDUCATION.

SUMMARY:

This bill specifically authorizes the Connecticut State University System (CSUS) to award doctoral degrees in nursing education. It expands the CSUS's degree-granting authority, which currently includes doctoral degrees in education; masters degrees and other graduate study in education; and liberal arts and career programs at the bachelors, masters, and sixth year level.
