Title: AN ACT REGULATING THIRD-PARTY ADMINISTRATORS AND RATE APPROVALS FOR CERTAIN HEALTH INSURANCE POLICIES.

Statement of Purpose: To require third-party administrators to be licensed by the Insurance Department, to establish standards for such licensure and the conduct of business by third-party administrators, to grant the Insurance Department access to certain books and records, and to provide enforcement authority to the Insurance Commissioner.
