Title: AN ACT CONCERNING THE HANDLING OF PROPERTY CLAIMS BY PUBLIC ADJUSTERS.

Statement of Purpose: To require that only public adjusters prepare or submit a property claim or negotiate such claim on behalf of the insured and to specify additional disclosure requirements in the written notice provided by a person performing repair or remediation work under a personal or commercial risk policy.
