Title: AN ACT CONCERNING MODIFICATIONS TO THE PURCHASED GAS, ENERGY AND TRANSMISSION RATE ADJUSTMENT CLAUSES.

Statement of Purpose: To make modifications to the provisions of the Department of Public Utility Control's purchased gas and energy adjustment clauses by requiring the department to hold a public hearing no less than annually in lieu of the current six-month requirement and specifying that the department hold a public hearing at any time for the purchased gas, energy and transmission rate adjustment clauses if the Office of Consumer Counsel files an application requesting such a hearing.
