**Title:** AN ACT CLARIFYING POSTCLAIMS UNDERWRITING.

**Statement of Purpose:** To distinguish short-term health insurance policies from those having a duration of one year or more for the purpose of the Insurance Commissioner's approval of rescinding, cancelling or limiting a policy, to limit the scope of an investigation into a suspected preexisting condition and to specify requirements for insurers or health care centers that accept telephonic applications for individual health insurance coverage.
