**Title:** AN ACT CONCERNING HEALTH CARE PROVIDER RENTAL NETWORK CONTRACT ARRANGEMENTS.

**Statement of Purpose:** To require listings of covered entities be updated at least every ninety days, to prohibit covered entities from granting subsequent access to third parties to health care services, discounted rates or fees established in contracts between health care providers and contracting entities, and to specify that violations are deemed unfair or deceptive insurance practices under section 38a-816 of the general statutes.
