Title: AN ACT CONCERNING ISSUANCE OF EMERGENCY CERTIFICATES AND THE SAFETY OF PATIENTS AND STAFF AT FACILITIES OPERATED BY THE DEPARTMENT OF MENTAL HEALTH AND ADDICTION SERVICES.

Statement of Purpose: To: (1) Allow certain licensed clinical social workers and advanced practice registered nurses who have completed specialized training in conducting direct evaluations through community support programs certified by Centers for Medicare and Medicaid Services to issue emergency certificates, and (2) ensure the safety and well-being of patients and staff at facilities operated by the Department of Mental Health and Addiction Services.
