**Title:** AN ACT IMPLEMENTING THE RECOMMENDATIONS OF THE PROGRAM REVIEW AND INVESTIGATIONS COMMITTEE CONCERNING WHISTLEBLOWERS.

**Statement of Purpose:** To implement the recommendations of the Program Review and Investigations Committee concerning whistleblowers, including to add a policy statement, to require the Attorney General and Auditors of Public Accounts to enter into a memorandum of understanding to handle complaints jointly, to allow them to reject complaints in certain circumstances and to refer complaints to other agencies, to require them to monitor the outcome of the complaint and to permit the complainant to be informed of the outcome.
