Title: AN ACT CONCERNING MILITARY OR VETERAN STATUS ON STATE-ISSUED FORMS AND PUBLICATIONS, BENEFITS FOR VETERANS AND STATE EMPLOYEES CALLED TO ACTIVE SERVICE AND THE DISPOSITION OF REMAINS OF MEMBERS OF THE ARMED FORCES.

Statement of Purpose: To require state agencies, departments and offices to include a question on any new forms or publications sent to the public asking if the recipient is a member of the armed forces or a veteran who would like information regarding veterans' benefits. A state agency, department or office that received a form or publication indicating that the sender is a member of the armed forces or a veteran who would like information regarding veterans' benefits would forward the individual's contact information to the Department of Veterans' Affairs to be added to the department's contact list.
