Title: AN ACT CONCERNING MEDICAID LONG-TERM CARE COVERAGE FOR MARRIED COUPLES.

Statement of Purpose: To require the Commissioner of Social Services to amend the Medicaid state plan so that the community spouse of an institutionalized individual receives the maximum protected amount, as determined by federal law, and the proceeds of a reverse mortgage loan is not treated as income for the purpose of qualifying for Medicaid benefits.
