Title: AN ACT CONCERNING UNINSURED AND UNDERINSURED MOTORIST COVERAGE FOR BODILY INJURY TO A NAMED INSURED OR RELATIVE.

Statement of Purpose: To require uninsured and underinsured motorist coverage for a motor vehicle or motorcycle owned by a named insured that is otherwise insured but is used without the authorization of the named insured and strikes the named insured or a household member as a pedestrian.
