Resolved by this Assembly:

- 1 That the recommendation of the Claims Commissioner, file number
- 2 22246 of said commissioner, that an award of fourteen thousand four
- 3 hundred dollars, payable from the appropriation to the office of the
- 4 State Fire Administrator, be granted to American Professional
- 5 Educational Services on its claim against the state in excess of seven
- 6 thousand five hundred dollars, is accepted and that payment of said
- 7 amount to said claimant is ordered.
