House Joint Resolution No. 66

The Committee on Judiciary reported through REP. FOX, G. of the 146th Dist., Chairperson of the Committee on the part of the House, that the joint resolution ought to be adopted.

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CLAIMS COMMISSIONER TO GRANT AN AWARD TO ICAC TASK FORCE, FOX VALLEY TECHNICAL COLLEGE ON ITS CLAIM AGAINST THE STATE.

Resolved by this Assembly:

- 1 That the recommendation of the Claims Commissioner, file number
- 2 22261 of said commissioner, that an award of twenty-three thousand
- 3 seventy-six dollars and ninety-five cents, payable from the
- 4 appropriation to the Department of Public Safety, be granted to ICAC
- 5 Task Force, Fox Valley Technical College, on its claim against the state
- 6 in excess of seven thousand five hundred dollars, is accepted and that
- 7 payment of said amount to said claimant is ordered.
