The Committee on Judiciary reported through REP. FOX, G. of the 146th Dist., Chairperson of the Committee on the part of the House, that the joint resolution ought to be adopted.

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CLAIMS COMMISSIONER TO GRANT AN AWARD TO ORV C. KARAN ON HIS CLAIM AGAINST THE STATE.

Resolved by this Assembly:

- 1 That the recommendation of the Claims Commissioner, file number
- 2 22450 of said commissioner, that an award of twelve thousand two
- 3 hundred fifteen dollars, payable from the appropriation to The
- 4 University of Connecticut Health Center, be granted to Orv C. Karan
- 5 on his claim against the state in excess of seven thousand five hundred
- 6 dollars, is accepted and that payment of said amount to said claimant
- 7 is ordered.
