It is in my opinion that my Dad was a victim of wrongful death not being able to get his records caused me anguish and despair and hindered the progress for justice.

St. Francis chose to give me pieces of his records not the complete chart after several attempts that proved to be unfruitful I lost counsel again not getting the complete records for them to study. Certain points of information were needed to institute a claim for negligence on St. Francis Hospital and my father's ex- wife Maureen Lynn Howe.

St. Francis deliberately withheld the records from me preventing my ability to prove that dad died from **Asbestos Disease, (interstitial Lung Disease)**.

The Ombudsmen Office was contacted by me in seeking help for his records and charts. Once that was accomplished with much diligence and resistance one of the Hospital Medical Personnel sat down with me to discuss the records.

A. St. Francis knew his diagnosis- Fibrosis in the Lungs / Family never informed, Pt wasn't informed

B. Disease not treated for, Medical records missing from file.

C. 7/15/03 X-ray taken showing fibrosis in the lungs, records missing from file.

These x-rays mysteriously disappeared from his medical history.

D. 5/13/06 pulmonary fibrosis present in lungs. Pt not aware and not recorded in medical history. The diagnosis disappeared once again.

E. 5/6/09 full blown pulmonary fibrosis that resulted in death with me holding him in my arms.


