AN ACT CONCERNING CHILDREN AND THE RECESSION.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. (NEW) (*Effective from passage*) (a) The Department of Social
2 Services, using the format prescribed by the results-based
3 subcommittee of the joint standing committee of the General Assembly
4 having cognizance of matters relating to appropriations and the
5 budgets of state agencies, shall submit a results-based accountability
6 report card on the policies and interventions promoted pursuant to
7 sections 17b-4a, 17b-112i, 17b-112j and 17b-749l and subsection (a) of
8 section 17b-800a of the general statutes. The department shall submit
9 the report card on or before January 1, 2012, and annually thereafter, to
10 the joint standing committee of the General Assembly having
11 cognizance of matters relating to appropriations and the budgets of
12 state agencies, in accordance with the provisions of section 11-4a of the
13 general statutes.

14 (b) The Department of Education, using the format prescribed by
15 the results-based subcommittee of the joint standing committee of the
16 General Assembly having cognizance of matters relating to

17 appropriations and the budgets of state agencies, shall submit a
18 results-based accountability report card on the policies and
19 interventions promoted pursuant to section 10-215h and subsection (b)
20 of section 17b-800a of the general statutes. The department shall
21 submit the report card on or before January 1, 2012, and annually
22 thereafter, to the joint standing committee of the General Assembly
23 having cognizance of matters relating to appropriations and the
24 budgets of state agencies, in accordance with the provisions of section
25 11-4a of the general statutes.

26 (c) The Department of Public Health, using the format prescribed by
27 the results-based subcommittee of the joint standing committee of the
28 General Assembly having cognizance of matters relating to
29 appropriations and the budgets of state agencies, shall submit a
30 results-based accountability report card on the policies and
31 interventions promoted pursuant to section 19a-59g of the general
32 statutes. The department shall submit the report card on or before
33 January 1, 2012, and annually thereafter, to the joint standing
34 committee of the General Assembly having cognizance of matters
35 relating to appropriations and the budgets of state agencies, in
36 accordance with the provisions of section 11-4a of the general statutes.

This act shall take effect as follows and shall amend the following sections:

To require the Departments of Social Services, Education and Public Health to prepare and submit annual results-based accountability report cards for the initiatives established in Public Act 10-133, An Act Concerning Children in the Recession.
