  - 8 "Sec. 501. (NEW) (*Effective from passage*) (a) Notwithstanding the
  - 9 provisions of section 9-750 of the general statutes, on and after the

10 effective date of this section, (1) no funds received by the State  
11 Treasurer under part III of chapter 32 of the general statutes and  
12 deposited in the General Fund shall be credited to the Citizens'  
13 Election Fund established in section 9-701 of the general statutes, and  
14 (2) no revenues from the tax imposed under chapter 208 of the general  
15 statutes shall be deposited in the Citizens' Election Fund.

16 (b) Notwithstanding the provisions of chapter 157 of the general  
17 statutes, no grants shall be paid from the Citizens' Election Fund.

18 Sec. 502. (*Effective from passage*) Notwithstanding the provisions of  
19 section 9-701 of the general statutes, on or after July 1, 2011, any funds  
20 remaining on June 30, 2011, in the Citizens' Election Fund established  
21 in section 9-701 of the general statutes shall be transferred from said  
22 fund and credited to the resources of the General Fund for the fiscal  
23 year ending June 30, 2012.

24 Sec. 503. Section 3-69a of the general statutes is repealed and the  
25 following is substituted in lieu thereof (*Effective from passage*):

26 (a) (1) For the fiscal year ending June 30, 2005, the funds received  
27 under this part, excluding the proceeds from the sale of property  
28 deposited in the Special Abandoned Property Fund in accordance with  
29 section 3-62h, shall be deposited in the General Fund.

30 (2) For the fiscal year ending June 30, 2006, [and each fiscal year  
31 thereafter] to the fiscal year ending June 30, 2011, inclusive, a portion  
32 of the funds received under this part shall, upon deposit in the General  
33 Fund, be credited to the Citizens' Election Fund established in section  
34 9-701 as follows: (A) For the fiscal year ending June 30, 2006, seventeen  
35 million dollars, (B) for the fiscal year ending June 30, 2007, sixteen  
36 million dollars, (C) for the fiscal year ending June 30, 2008, seventeen  
37 million three hundred thousand dollars, and (D) for the fiscal year  
38 ending June 30, 2009, [and each fiscal year thereafter] through the fiscal  
39 year ending June 30, 2011, inclusive, the amount deposited for the  
40 preceding fiscal year, adjusted in accordance with any change in the  
41 consumer price index for all urban consumers for such preceding fiscal

42 year, as published by the United States Department of Labor, Bureau  
43 of Labor Statistics. The State Treasurer shall determine such adjusted  
44 amount not later than thirty days after the end of such preceding fiscal  
45 year.

46 (b) All costs incurred in the administration of this part, except as  
47 provided in section 3-62h and subsection (a) of this section, and all  
48 claims allowed under this part shall be paid from the General Fund.

49 Sec. 504. Section 166 of public act 11-6 is repealed and the following  
50 is substituted in lieu thereof (*Effective from passage*):

51 Subdivisions [(47),] (48), (52), (95), (97) and (111) of section 12-412  
52 and section 12-412b of the general statutes are repealed.

53 Sec. 505. Section 110 of public act 11-6 is repealed. (*Effective from*  
54 *passage*)"
