Title: AN ACT CONCERNING THE PLACEMENT OF CHILDREN IN OUT-OF-STATE TREATMENT FACILITIES.

Statement of Purpose: To return to Connecticut the children in the care and custody of the Commissioner of Children and Families that are placed in out-of-state treatment facilities, unless a court determines it is necessary, appropriate and in a child's best interest to be placed in an out-of-state treatment facility, and to track the race of certain groups of children in the custody of the Department of Children and Families.
