Title: AN ACT CONCERNING THE SUNSET DATE FOR PERSONAL RISK INSURANCE RATE FILINGS AND THE PROCUREMENT OF REINSURANCE BY DOMESTIC TITLE INSURERS.

Statement of Purpose: To extend the sunset date for personal risk insurance filings and prohibit an insurer that discontinues accepting applications for a line or subline of personal risk insurance in this state from filing a rate increase for such line or subline of more than six per cent.
