**Title:** AN ACT CONCERNING THE HIGH SCHOOL DROPOUT AGE AND NOTIFICATION OF FAILING STUDENTS.

**Statement of Purpose:** To conduct a study about interdistrict magnet schools; to raise the age that a student may drop out of school to eighteen; and to require principals to notify the parents or guardians of a student that such student is in danger of failing a course or courses at least six weeks before the grade in such course or courses is finalized.
