**Title:** AN ACT CONCERNING OFFERS OF COMPROMISE IN CONSTRUCTION CONTRACT ARBITRATION PROCEEDINGS, MEDIATION AND ARBITRATION OF CONSTRUCTION CONTRACTS, AND ETHICAL VIOLATIONS CONCERNING BIDDING AND STATE CONTRACTS.

**Statement of Purpose:** To: (1) Allow a party in an arbitration proceeding on a construction contract to submit an offer of compromise to the other party and provide that the party who files such offer of compromise may recover eight per cent annual interest on the amount of any award equal to or in excess of the amount in the party's offer; and (2) clarify that certain construction contract provisions may not include the requirement that disputes be adjudicated outside this state by mediation or arbitration.
