Title: AN ACT CONCERNING MENTAL OR NERVOUS CONDITIONS UNDER THE CONNECTICUT UNFAIR INSURANCE PRACTICES ACT.

Statement of Purpose: To add to the list of unfair insurance practices the refusal to insure, the refusal to continue to insure or a limitation of the amount, extent or kind of coverage available to an individual or the charge of a different rate for the same coverage because such individual has been diagnosed with a mental or nervous condition as set forth in section 38a-488a of the general statutes.
