Title: AN ACT CONCERNING INSURANCE COVERAGE FOR THE SCREENING AND TREATMENT OF PROSTATE CANCER AND PROHIBITING DIFFERENTIAL PAYMENT RATES TO HEALTH CARE PROVIDERS FOR COLONOSCOPY OR ENDOSCOPIC SERVICES BASED ON SITE OF SERVICE.

Statement of Purpose: To require health insurance coverage for (1) external radiation beam therapy and brachytherapy for the treatment of prostate cancer, and (2) phosphodiesterase-5 inhibitor prescription drugs for the treatment of erectile dysfunction resulting from a radical prostatectomy.
