**Title:** AN ACT CONCERNING REVISIONS TO THE STATUTES REGARDING THE MINIMUM BUDGET REQUIREMENT AND CHARTER SCHOOL EDUCATOR PERMIT.

**Statement of Purpose:** To study issues relating to school transportation; to require the Performance Evaluation Advisory Council to develop a model teacher performance evaluation system for use by local and regional boards of education and regional educational service centers; and to include employment in a cooperative arrangement as part of the definition of tenure for purposes of teacher tenure laws.
