***AN ACT PROVIDING FEDERAL PROBATION OFFICERS WITH
ACCESS TO FIREARM DATA REGARDING PROBATIONERS.***

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. Subsection (d) of section 29-28 of the general statutes is
2 repealed and the following is substituted in lieu thereof (*Effective*
3 *October 1, 2012*):

4 (d) Notwithstanding the provisions of sections 1-210 and 1-211, the
5 name and address of a person issued a permit to sell at retail pistols
6 and revolvers pursuant to subsection (a) of this section or a state or a
7 temporary state permit to carry a pistol or revolver pursuant to
8 subsection (b) of this section, or a local permit to carry pistols and
9 revolvers issued by local authorities prior to October 1, 2001, shall be
10 confidential and shall not be disclosed, except (1) such information
11 may be disclosed to law enforcement officials acting in the
12 performance of their duties, including, but not limited to, employees of
13 the United States Probation Office acting in the performance of their
14 duties, (2) the issuing authority may disclose such information to the
15 extent necessary to comply with a request made pursuant to section
16 29-33 for verification that such state or temporary state permit is still

17 valid and has not been suspended or revoked, and the local authority
18 may disclose such information to the extent necessary to comply with
19 a request made pursuant to section 29-33 for verification that a local
20 permit is still valid and has not been suspended or revoked, and (3)
21 such information may be disclosed to the Commissioner of Mental
22 Health and Addiction Services to carry out the provisions of
23 subsection (c) of section 17a-500.

24 Sec. 2. Subsection (e) of section 29-36g of the general statutes is
25 repealed and the following is substituted in lieu thereof (*Effective*
26 *October 1, 2012*):

27 (e) Notwithstanding the provisions of sections 1-210 and 1-211, the
28 name and address of a person issued an eligibility certificate for a
29 pistol or revolver under the provisions of section 29-36f shall be
30 confidential and shall not be disclosed, except (1) such information
31 may be disclosed to law enforcement officials acting in the
32 performance of their duties, including, but not limited to, employees of
33 the United States Probation Office acting in the performance of their
34 duties, (2) the Commissioner of Emergency Services and Public
35 Protection may disclose such information to the extent necessary to
36 comply with a request made pursuant to section 29-33 for verification
37 that such certificate is still valid and has not been suspended or
38 revoked, and (3) such information may be disclosed to the
39 Commissioner of Mental Health and Addiction Services to carry out
40 the provisions of subsection (c) of section 17a-500.

41 Sec. 3. Subsection (a) of section 53-202d of the 2012 supplement to
42 the general statutes is repealed and the following is substituted in lieu
43 thereof (*Effective October 1, 2012*):

44 (a) Any person who lawfully possesses an assault weapon, as
45 defined in section 53-202a, prior to October 1, 1993, shall apply by
46 October 1, 1994, or, if such person is a member of the military or naval
47 forces of this state or of the United States and is unable to apply by
48 October 1, 1994, because he or she is or was on official duty outside of

49 this state, shall apply within ninety days of returning to the state to the
50 Department of Emergency Services and Public Protection, for a
51 certificate of possession with respect to such assault weapon. The
52 certificate shall contain a description of the firearm that identifies it
53 uniquely, including all identification marks, the full name, address,
54 date of birth and thumbprint of the owner, and any other information
55 as the department may deem appropriate. The department shall adopt
56 regulations in accordance with the provisions of chapter 54 to establish
57 procedures with respect to the application for and issuance of
58 certificates of possession pursuant to this section. Notwithstanding the
59 provisions of sections 1-210 and 1-211, the name and address of a
60 person issued a certificate of possession shall be confidential and shall
61 not be disclosed, except such records may be disclosed to (1) law
62 enforcement agencies and employees of the United States Probation
63 Office acting in the performance of their duties, and (2) the
64 Commissioner of Mental Health and Addiction Services to carry out
65 the provisions of subsection (c) of section 17a-500.
